Dear LTC Residents and Family Members:

Re: Notice of Accommodation Fee Adjustment – July 1, 2017

As you know, Albertans residing in designated supportive living and long-term care facilities are responsible for paying a monthly accommodation charge. The *Nursing Homes Operation Regulation* prescribes the amount operators can charge long-term care residents based on room type; these same charges apply to designated supportive living units.

Based on a recent announcement and related approval by the Provincial Government, the accommodation charge will be increased on July 1, 2017 based on the Alberta Consumer Price Index, for the period from March 1, 2016 to February 28, 2017 (and rounded to the nearest \$0.05). During this period of time the Alberta CPI was **2.2%**.

Therefore, effective July 1, 2017, the new monthly accommodation charges will be as follows:

Effective July 1, 2017 (based on 2.2% increase in Alberta Consumer Price Index *)

Room Type	Daily	Adjustment
Private Room A	\$65.50	\$1.40/day
Private Room B	\$61.10	\$1.30/day
Semi-private	\$56.65	\$1.20/day

Government income supports related to the above charges will continue to be available to eligible low-income clients.

These charges reflect the monthly amount you pay for your accommodation-related services such as meals, housekeeping, utilities and routine building maintenance. These measures assist in covering cost increases to services such as food and lodging incurred by facility operators over the past several years.

Thank you for your continued patronage and understanding. These government approved accommodation charge adjustments will help enable Intercare, as your chosen facility operator, to continue to provide well maintained facilities and quality services to all our valued clients.
